Social media cases up by 40 per cent

ASES coming before the courts involving malicious and offensive use of social media have jumped by almost 40 per cent in the past year.

More than 800 files involving alleged public electronic communications offences have been passed to the Public Prosecution Service (PPS) since 2010.

Almost 260 cases were dealt with last year - a surge of almost 40 per cent on the 186 cases in 2011.

In a recent high profile case a Belfast city councillor has found herself facing charges offensive online comments.

Former DUP Belfast deputy lord mayor Ruth Patterson (57) appeared in court last month to face charges of sending a message on Facebook be deemed to grossly offensive.

The 57 year-old, who is due before court again in October, is to contest the charge.

The latest figures emerge amid increasing fears over ma-

licious messages being sent over the internet.

Recently The Irish News revealed that police were investigating online comments made by a loyalist bandsman, in which he said he was "praying" that a bomb would kill Catholic residents in Ardoyne, north Belfast.

Concerns have also been raised over Twitter trolls people who send abusive messages using the social network - threatening rape and violence against women.

Labour MP Stella Creasy is among a host of recent highprofile targets.

Social media site Ask.fm has criticised after it emerged that 14-year-old Leicestershire schoolgirl Hannah Smith took her own life due to cyberbullying.

Mark Jackson, a partner at Thompsons Solicitors in Newtownards and specialising in social media issues, said it was increasingly becoming a more significant legal issue.

"Because people have instant access to all sorts of social media platforms it is becoming more of an issue for the law to keep up with," he

The figures were obtained by The Irish News through a Freedom of Information request to

A total of 801 files involving complaints relating to Section 127 of the Communications Act were received by the PPS since 2010.

Offences under the act include menacing and malicious messages through a public communications network, and improper use of public electronic communications.

The PPS received files for 199 cases in 2010, followed by a further 186 in 2011 and 256 last vear.

A total of 160 cases have been sent to public prosecutors for consideration between January and July this vear.

Since 2010, the PPS has sought prosecution in almost 420 cases, while a further 90 cases have been dealt with by diversion measures such as cautions.
